Preparing Abstracts, Oral presentations and Poster presentations for CEM India 2019.

The goal of the conference is to foster informative and active discussions on the technical, regulatory and safety issues associated with emission and effluent quality monitoring. With this goal in mind, Oral and Poster presentations must be technically focused with commercial aspects kept to an absolute minimum.

Selected oral presentations will be allocated a 20-minute presentation slot in the main CEM India conference and selected poster presentations will be allocated a poster board in the poster area.

Abstract submission- Guidelines

Abstract submission will be open from the 18th February 2019 and close on the 15th March 2019. Presenters should submit a short abstract using the [abstract submission portal](#). The abstract should give an overview of the proposed oral or poster presentation.

Presentation- Guidelines

1. Oral Presentation Guidelines

- Guideline 1 - Each presentation slot is of 20 minutes including the time for Q&A. This means that you should plan your talk to last 15-16 minutes maximum and remaining 4-5 minutes for Q&A. We suggest allowing on average of 1-2 slides per minute. However, pictures give more information than numbers - use the best means to get your subject across. Remember, the audience will represent many different countries, so keep the slides simple so that non-native English speakers can understand your results. Please note that, CEM India is NOT a forum for advertising, **therefore the presentations that come across as sales-pitch are not acceptable. If you wish to enhance the potential to sell any piece of equipment to the extensive group of delegates, please make sure you book an [exhibition stand](#) as soon as possible as there are few spaces left.**
- Guideline 2 - Please provide your presentation in Microsoft PowerPoint slides **to us by 13th September 2019**. We will then convert all presentation into power point show files with interlinking slides.
- Guideline 3 - Whilst diagrams often help to simplify and demonstrate complex theories or results, complicated spectra rarely do more than confuse the audience. Please keep diagrams and tables simple – no more than 8 rows/columns – or the slide will be unreadable.

2. Poster Presentation Guidelines

- Guideline 1 - Posters must be in portrait orientation (vertical) and not to exceed 90cm wide by 180cm tall. Posters in landscape orientation (horizontal) will not fit on the poster boards being used at the conference
- Guideline 2 - We advise that poster presenters use A0 sized posters which are 84cm x 119cm
- Guideline 3 - All poster presenters must be registered.
- Guideline 4 - The poster boards are made of shell scheme type material and work with sticky hooks and loops which will be provided.
